IOM North Kivu – Emergency Program Weekly Report from 25 to 31 October 2013

1. Emergency operations, coordination, information management and site management

- **25 October 2013:** Mission to Rubaya to finalize the update of IDP lists and mapping of the 3 spontaneous sites in the area.
- **25 October 2013:** Joint mission with Governmental Entities in Sake for the identification of new land for contingency plan.
- **27 October 2013:** Monitored IDP movements on the Kanyaruchinya Axis following heavy fighting over the weekend. IOM worked closely with the MONUSCO and Civil Protection for the whole day.
- **28 October 2013:** Rapid Assessment conducted by IOM jointly with the Civil Protection in Kanyaruchinya and finalized the map depicting distributions of IDP households residing in collective centers.
- **28 October 2013:** Recording of new households reported in Bweremana and kibabi-Buporo in the database.
- **29 October 2013:** Commenced mapping of gaps in the spontaneous sites covered by IOM.
- **29 October 2013:** Prepared and distributed lists to partners regarding WASH for Kibabi-Kishusha and verification/management for Luve.
- **29 October 2013:** Preparation for and undertaking of a night mission to Lac Vert for fixing of the IDP's residing in the Emergency Collective Shelters.
- **29/30 October 2013:** Began entering data pertaining to IDP's in Luve, Ngoroba.
- **29 October 2013:** Following up of WFP food distribution activities in Buhimba, Mugunga 1 and Bulengo after the election of new sectoral committees in Buhimba.
- **30 October 2013:** Monitoring of distributions in Buhimba, Lac Vert and Magunga 1.
- **30 October 2013:** Evaluation of shelter needs in Bulengo.

2. Assessments

- **28 October 2013:** Follow-up assessment in Kanyaruchinya. Visited 13 collective centres in the region and estimated IDP population distributions.
- **29 October 2013:** Conducted a 3rd assessment in Kanyaruchinya confirming 80% of households had returned to their villages of origin. IOM was the agency feeding OCHA with the information, in coordination with the Civil Protection.
- **30 October 2013:** Evaluation of shelter needs in Bulengo.

3. Meetings / Visits

- **28 October 2013:** IOM coordinated a meeting with OCHA and UNHCR and the recent movements in Kanyaruchinya.
- **28 October 2013:** IOM chaired the Spontaneous Site WG meeting.
- **28 October 2013:** IOM participated in the CPIA meeting during which a light presentation of the CCCM Strategy was presented. IOM and UNHCR must agree soon on the full CCCM Provincial Strategy to be presented to the CPIA on 18 November 2013. Also, the issue of WFP pipeline has been broadly tackled.
- **30 October 2013:** Vulnerability Harmonization Meeting with UNHCR, NGO partners at WFP.
- **29-31 October 2013:** Félicien Mibulo was deployed on TDY to discuss and meet partners about the South Irumu crisis and a possible involvement of IOM Bunia, with the support of Goma Office.
- **30 October 2013:** Joint meeting with WFP, IOM and UNHCR regarding the vulnerability criteria with regards to food assistance in all sites and camps as of December 2013.
- **31 October 2013:** IOM participated in the Intercluster meeting during which the following points have been discussed: possible returns in Nyiragongo and Rutshuru Territories, WFP pipeline issue and strategy, gaps in the North of Masisi.
- **31 October 2013:** A Senior Staff Meeting was held to discuss achievements and current challenges.

4. Protection issues

- **25 October 2013:** Protection cluster meeting and evaluation of protection needs in IDP sites and camps in North Kivu.
- **28 October 2013:** Protection assessment in Bulengo and follow up of individual cases.
- **29 October 2013:** Meeting with the National Commission for Refugees (CNR) concerning the forced eviction in Katale.
- **29 October 2013:** Follow up of individual protection cases in Kishusha.
- **30 October 2013:** Protection monitoring in all IDP sites in conjunction with DRC and PU-AMI.
- **31 October 2013:** Meeting with the CNR regarding population movements in Rubaya and security incidents in Kishusha.
